Program Information 2015 DreamPower Foundation, Inc. Accomplishments in 2015 DreamPower Foundation, Inc. (DBA DreamPower Horsemanship) provided equine-assisted activities and therapies to 711 individuals in 2015 through 19 unique programs. More children, teens and adults between the ages of 3-85 participated in DreamPower's programs in 2015 than any other year so far. We met our goal of providing services to more than 200 U.S. military veterans, active duty military personnel and their families. The new DreamPower website was launched. New DreamPower programs in 2015 included The LEOS (Law Enforcement Officers Support) Project, a new partnership with VITAS Hospice, Mounted Yoga classes and hosting a PATH Intl. Equine Specialist in Mental Health and Learning Workshop. Programs and services offered in 2015 included an ongoing research study of The Social and Emotional Effects of Group Therapeutic Horseback Riding Lessons for Children on the Autism Spectrum, Ponies and Preschoolers (Kindergarten readiness program), Summer Camp for Children with Special Needs, Living Strong with MS (Multiple Sclerosis), Horses for Warriors (for U.S. military veterans and their families), Mounted EMDR (eye movement desensitization and reprocessing a VA-approved treatment for trauma), equine facilitated psychotherapy, equine facilitated learning, therapeutic horsemanship lessons, the Equine Journey Wilderness Program, a Womens Personal Growth Group, Farm Friends (childrens social skills program) and the therapist/intern training program. In 2015 DreamPower continued partnering with Operation Freedom Paws to provide psychotherapy services to military veterans and others with disabilities in the Operation Freedom Paws service dog training program. In February 2015 DreamPower was honored by the Gilroy Chamber of Commerce as their 2015 Non-profit of the Year. Also in February 2015, Pete (one of the DreamPower therapy horses) was inducted into the Horse Stars Hall of Fame, as the winner of the 2014 PATH Intl. Therapy Horse of the Year. You can see Petes award at www.horsetarshalloffame.org. In March 2015 DreamPower hosted the Iraq and Afghanistan Veterans of America Day at the Ranch with the IAVA. In April 2015 DreamPower staff taught a masters level course for John F. Kennedy University on equine therapy for combat veterans. In June 2015 DreamPower hosted approximately 130 members of law enforcement families at the first Law Enforcement Family Day at the Ranch. In July 2015 DreamPower horses and volunteers appeared in the Morgan Hill Fourth of July Parade and assisted with the Sunnyvale Elks Day at the Ranch for children on the autism spectrum. In Sept. 2015 DreamPower hosted a PATH Intl. Equine Specialist in Mental Health and Learning On-site Workshop and Certification. In Oct. 2015 DreamPower hosted an Equine Journey Wilderness Program camping trip with the Santa Clara County Office of Education Adaptive Physical Education Department. In Nov. 2015 DreamPower hosted the second Law Enforcement Family Day at the Ranch. In Dec. 2015 DreamPower was chosen by Whole Foods Market Blossom Hill, CA as the non-profit to receive their 5% Day donations. In 2015, DreamPower partnered with the Santa Clara County Office of Education Adaptive Physical Education Department, Learning Services, Advent Group Ministries, Chamberlain Childrens Services, Community Solutions, the Bill Wilson Center, the Palo Alto VA, the San Jose Vet Center, the Santa Cruz Vet Center, John F. Kennedy University, InnVision/Shelter Network, San Jose Police Department, the Sunnyvale Elks Lodge, VITAS Hospice, Operation Freedom Paws, PATH International and many other non-profit organizations in the community.
