As the fiscal sponsor, Fresh Arts provides fiduciary oversight, financial management, and other administrative services to help build the capacity of charitable projects. Access to fiscal sponsorship in Houston is creating a whole new class of professional artists who have a mechanism to receive support for their work, the freedom to be innovative without excessive administrative burden, and the privilege to focus on their given areas of expertise. Fresh Arts has overseen the disbursement of over 350,000 in funds to worthy arts projects since its pilot year in 2013.

Provide income generation opportunity for artists and arts organizations. Winter Holiday Art Market, Cultured Cocktails, Community Sponsored Art In 2015, Fresh Arts celebrated its 10th Annual Winter Holiday Art Market WHAM, a juried art market and celebration of Houston's talented and diverse artists. Since its launch, WHAM has generated nearly 900,000 for hundreds of local artists and continues to grow as an important venue for Houston artists. Cultured Cocktails celebrates a local arts group every Thursday and provides an opportunity for audiences and supporters to get up close and personal with the artists that make Houston unique with ten percent of happy hour sales benefiting the participating artists. Community Sponsored Art creates a pipeline between local artists and patrons.

Provide professional development opportunities. Workshops, M-LAB, Gallery Play Days and online resources. Community Art Calendar, Arts Directory, Resources for Artists, Art on Tap for artists and arts organizations. Fresh Arts hosts career-building workshops for artists and arts administrators to support their professional growth, hosts M-LAB which provides one-on-one consultation to small arts groups to explore new marketing strategies to better engage existing and new audiences, and offers Gallery Play Days which equip artists with the skills and expertise to proactively self-produce their exhibitions and performances. Fresh Arts also provides artists and arts organizations with access to as-needed, on-demand resources to enhance the marketing of their work and strengthen their capacity to succeed in the business of art.
