Nutcracker performances attracted over 4,200 people from Dalton and surrounding communities who attended 8 sold out performances. Dalton Arts Project brought in professional artists and more than 350 local performers, children and adults, for Northwest Georgia's premier holiday event. The ticket subsidy program allowed many low-income families and children to attend, who would not otherwise be able to.

As part of Dalton Arts Project's ArtReach (taking arts into the community), Dalton Dance Company presented 10 community performances with more than 1,150 people attending their spring concert "March Madness". Chorus Peregrinus, the performing choral group, presented 3 concerts. During the year, Dalton Arts Project extends its ArtReach by partnering with and bringing the arts to Cherokee Estates, Friendship House, Dalton-Whitfield Daycare, Helping the Hurting, NWGA Girls' Home, the Senior Citizens' Center, the Crisis Center, Big Brothers/Big Sisters, DHS Performing Arts and other organizations, DanceArts Camps, scholarships, ticket subsidy program, clothing drive, and outreach performances. Our Club D service group, comprised of many Dalton Dance Company members provided more than 3,000 hours of volunteer services to the community and through their "Dancing for a Cause" project, have raised funds over the last 10 years for Haitian Relief Fund, Breast Cancer Awareness, Make-A-Wish Foundation, Katrina Relief Fund, Dalton Education Foundation, and the Epilepsy Foundation.
