OUR VITA SITE PROVIDED FREE TAX PREPARATION FOR 1,093 INDIVIDUALS OR FAMILIES DURING THE 2015 TAX SEASON. OF THESE FAMILIES, 501 WERE ELIGIBLE FOR THE EARNED INCOME TAX CREDIT (EITC). EITC CLAIMS FOR VITA CLIENTS TOTALLED 852,814. IN ADDITION, OUR TCE SITE, WHICH OFFERS FREE TAX PREPARATION FOR ANYONE OVER THE AGE OF 60, PREPARED 553 TAX RETURNS DURING 2015. EIGHTY-SIX TCE CLIENTS WERE ELIGIBLE FOR THE EITC CREDIT TOTALING 136,632 IN CLAIMS THROUGH OUR TCE SITE. BOTH SITES UTILIZE IRS-CERTIFIED VOLUNTEERS TO PREPARE AND FILE THE RETURNS. 2.3 MILLION IN TOTAL REFUNDS. UNITED WAY OF FAIRFIELD COUNTY ALSO PROVIDED ASSISTANCE TO HIGH SCHOOL STUDENTS AND THEIR FAMILIES FILING FOR THE FAFSA. SEVEN LOCAL HIGH SCHOOLS PARTNERED WITH UNITED WAY TO SET UP FAFSA PREPARATION CLASSES WHERE UNITED WAY STAFF ASSISTED IN COMPLETING THE APPLICATION PROCESS.
