 The Mueller Society Employee Giving Campaign is an annual voluntary campaign in support of Miami Valley Hospital employees. It provides programs and services for employees by providing an employee catastrophic emergency relief program, hospital department grants program, and youth scholarship program for eligible employees dependents. In 2015, 21 Catastrophic grants were awarded to employees, three department grants were awarded, and 171 scholarships were awarded.

4b (Code) (Expenses \$ 92,229 including grants of \$ 92,229) (Revenue \$ 0)
 Miami Valley Hospital Foundation raised funds for the diabetes inpatient team which provides education for hospitalized patients from certified diabetes educators based at the Bull Family Diabetes Center. Inpatient Diabetes Education addresses the "survival and safety" needs of the newly-diagnosed patients, a change in treatment or medication, or provides focused education to improve diabetes self-management skills. In 2015, the diabetes educators completed 1,826 patient visits.

 Through the hospital's home health provider, Miami Valley Hospital Foundation provided funding for an Advanced Illness Management Health Coach to provide education and care coordination to improve patient self-management of chronic illness. In addition, the Foundation also provided a comprehensive program for Chronic Obstructive Pulmonary Disease (COPD) patients with an emphasis on Respiratory Therapy Intervention, to help patients and their caregivers better understand how to manage their disease at home.
