

training program tied to a housing incentive for residents to work and live within  
the depressed, inner city urban enterprise zone. The association plus an independent  
contractor to attend meetings to take notes and transcribe official minutes. We  
also paid a small amount to a public relations professional to develop a bilingual  
brochure describing the urban enterprise zone and its benefits. The brochure is  
available to the general public.
