CareSource, a leading nonprofit managed care organization based in Dayton, Ohio, has been living its mission to make a lasting difference in our members' lives by improving their health and well-being for more than 26 years. CareSource serves more than 1,300,000 million Medicaid members in Ohio. CareSource's spectrum of those served include: (1) Medicaid consumers, including families with low income, children, pregnant women, those who are aged, blind or disabled, and those who are eligible for Home and Community Based services through execution of an annual Provider Agreement with the Ohio Department of Medicaid (ODM); (2) Dually eligible consumers for Medicaid and Medicare through Ohio's Dual Demonstration program, MyCare, and (3) Qualified Health Plans, called CareSource Just4Me, offered through the Federal Health Insurance Exchange, providing low-cost comprehensive coverage for uninsured individuals and families. CareSource pioneered Ohio's first mandatory Medicaid managed care program in 1989, and is now one of the largest Medicaid managed care plans in the country. CareSource's years of experience in managing Medicaid managed care programs and member focused approach to care, have allowed CareSource the opportunity to forge strong, positive regulatory relationships with state agencies, including departments of insurance. In Ohio, CareSource has earned over 53% of the statewide managed care market share, with the highest voluntary enrollment rate and the lowest voluntary disenrollment rate of all participating Medicaid Managed care plans. CareSource focuses on prevention with a goal of improving member health, the quality of health care services received, and accessibility of health care services for Medicaid members. This is done through an innovative health and wellness methodology. CareSource has a broad, statewide network of more than 80,000 providers, including primary care and specialist physicians, hospitals, nursing facilities, home health care agencies and other medical providers who provide medical services as well as assist in the coordination of member care for CareSource's Medicaid, MyCare and Just4Me members. Additionally, CareSource offers 24-hour nurse call center services staffed by Registered Nurses, to help members access appropriate care and divert unnecessary emergency department visits. CareSource's commitment to quality is demonstrated through the organization's National Committee for Quality Assurance (NCQA) and URAC accreditations. CareSource is Accredited for the Medicaid HMO Health plan by NCQA. NCQA is a private, nonprofit organization dedicated to transforming health care quality through measurement, transparency and accountability. NCQA consistently raises the bar on health care plan performance by continually increasing quality improvement standards. CareSource maintained its URAC full accreditation for compliance with health utilization management and health call center. Accreditation by both NCQA and URAC demonstrate CareSource's commitment to quality and enhances CareSource's ability to improve the health and well-being of those we serve. CareSource's community-based care coordination program serves members who have the greatest need for case management services. Members receive enhanced care management services based on their complex physical, behavioral and social health needs. CareSource's community-based team of nurses, social workers and Community Health Workers, works in the community to guide members through the complex and often-confusing medical and social service systems. CareSource collaborates with community partners and providers such as the Area Agencies on Aging, Community Mental Health Centers, local pharmacies, and Federally Qualified Health Centers to ensure members receive the services they need. CareSource also participates in the MyCare program as part of Ohio's Dual Demonstration program. CareSource entered into a three-way contract with Ohio Medicaid and the Centers for Medicare and Medicaid Services (CMS) to serve members who are dually eligible for both Medicare and Medicaid. By integrating Medicaid and Medicare services, CareSource is helping Ohioans achieve better health outcomes, thereby reducing unnecessary or redundant costs from fragmented health systems. Through MyCare, CareSource members receive person-centered care management that coordinates their physical, behavioral, long-term care, and social needs. Through a contract with ODM, CareSource manages members in the Columbus, Cleveland and Manetta regions of Ohio (67 counties) who are eligible for the Home and Community Based Services (HCBS) waiver, also known as the Ohio Home Care Waiver. Through this program, CareSource provides in-home and community-based care management services that help individuals remain at home instead of residing in a nursing home or other long-term care facility. CareSource serves nearly 2,000 members in the Medicaid waiver program. CareSource Just4Me, an important part of the Organization's mission to serve the uninsured, offers affordable coverage to those who qualify through low premiums, copayments and deductibles. CareSource's ground breaking Job-Connect program is part of CareSource's Life Services initiative. The Job-Connect program recognizes the barriers an individual may have in preparing, securing, and performing at a sustainable level necessary to secure long term employment. CareSource has extended the expertise of CareSource University (CSU), our nationally recognized training program, by offering a job preparation course to our members that includes life and workplace skills. CareSource's Job Connect program incorporates training and preparing candidates for interviews by addressing topics such as computer literacy, appearance and dress for success, office etiquette and professional relationships, resume writing, and interviewing skills. Once a candidate successfully secures employment, CareSource continues the journey, supporting them with ongoing coaching to ensure success during the initial stages of employment. CareSource's Life Services initiative, in combination with Job-Connect, aims to make a sustained impact in members' lives by effectively addressing the obstacles that impede progress in a member's journey toward self-sufficiency, improved health, and well-being. CareSource is recognizing community employment partners that have been part of the Life Services program by providing job opportunities and resources to Medicaid members. Over 40 employers have worked with the CareSource Life Services Program to place 125 people into jobs since the program began in 2014. The CareSource Life Services program was created to help low-income individuals navigate the system of available resources to reach economic stability. The program has over 100 community resource partners and organizations including (1) Food banks, (2) Job training centers, (3) Mental health agencies, (4) Housing agencies, (5) Churches, (6) Schools, and (7) Financial counseling services. Approximately 900 Dayton-area Medicaid members in 8 counties are currently enrolled in the Life Services Program. CareSource Life Coaches assist members by (1) Identifying employment opportunities, (2) Finding reliable child care, (3) Providing interview preparation, and (4) Organizing dependable transportation. CareSource's innovative programs aim to improve health outcomes, while remaining member focused and treating the whole person. CareSource addresses not only a member's medical issues, but also a member's psychosocial issues that can create barriers to receiving quality health care. CareSource has partnered with Outcomes MTM to deliver a Medication Therapy Management (MTM) program. The program provides focused MTM services, including face-to-face member visits with pharmacy staff. Pharmacists provide complete medication reviews to help members with their medications. By providing this service, the organization has decreased unnecessary hospitalizations and emergency department visits. CareSource is one of only a few Medicaid plans to voluntarily provide this service to its members. CareSource provides enhanced benefits to members that are above and beyond required benefits defined by state or federal agencies. Together, these enhanced benefits provide CareSource members additional program benefits in order to make a lasting difference in our members' lives by improving their health and well-being. In 2015, CareSource paid over \$45 Million to fund these enhanced benefits, including the following: (1) Transportation, \$24,246,000, (2) Rx (Pharmacy) Co-Pay, \$ 8,644,000,, (3) Outcomes MTM, \$7,867,000, (4) Dental, \$ 1,602,000, (5) Non-Emergent ER Co-Pay, \$1,459,000, (6) Babies First, \$582,000, (7) Vision Exams and Vision Hardware, \$384,000, and (8) Silver Sneakers, \$235,000.
