THE ORGANIZATION CAN ASSIST IN OBTAINING FURNITURE AND HOUSEHOLD ITEMS. ONCE HOUSED, CASE MANAGERS MEET WITH CLIENTS ON A REGULAR BASIS FOCUSING ON AREAS SUCH AS BASIC LIVING SKILLS, PARENTING, BUDGETING, PHYSICAL HEALTH CARE, SUBSTANCE ABUSE, MENTAL HEALTH COUNSELING AND ADVOCACY WITH OTHER AREA AGENCIES. THE ORGANIZATION PARTNERS WITH MANY COMMUNITY ORGANIZATIONS TO PROVIDE SUPPORTIVE HOUSING SERVICES FOR SEVERAL LOCAL MULTI-UNIT HOUSING PROJECTS. HOMEFULL ASSESSED, TRIAGED AND/OR CASE MANAGED OVER 2,000 HOUSEHOLDS IN 2015. OVER 800 HOUSEHOLDS WERE HOUSED POSITIVELY FROM THE GATEWAY SHELTERS, INCLUDING OVER 200 FAMILIES WITH CHILDREN. THE AVERAGE LENGTH OF STAY IN SHELTER IN 2015 WAS 63 DAYS. MANY SHELTER CLIENTS EXIT TO PERMANENT HOUSING OPTIONS SUCH AS FAIR MARKET RENT, PERMANENT SUPPORTIVE HOUSING, OR MOVING IN PERMANENTLY WITH FRIENDS AND FAMILIES. LESS THAN 20% RETURN TO HOMELESSNESS.

THROUGH HOMEFULL'S ASSESSMENT, TRIAGE AND HOUSING FOCUSED CASE MANAGEMENT, WE SERVICED ALMOST 2,000 MEN, WOMEN AND CHILDREN IN THE GATEWAY SHELTERS IN 2015. MOST WERE PROVIDED ASSISTANCE RANGING FROM HYGIENE PRODUCTS TO START UP HOUSEHOLD ITEMS. HOMEFULL FOCUSES ON AREAS SUCH AS BASIC LIVING SKILLS, PARENTING EDUCATION, LITERACY AND PHYSICAL AND MENTAL HEALTH CARE. OVER 75% EXITED TO PERMANENT HOUSING DESTINATIONS.

IN 2015, HOMEFULL'S PREVENTION PROGRAMS SCREENED, ASSESSED, AND/OR PROVIDED ASSISTANCE TO OVER 200 HOUSEHOLDS. OF THOSE RECEIVING ASSISTANCE, LESS THAN 10% ENTERED INTO HOMELESSNESS. RAPID RE-HOUSING PROGRAMMING ASSISTS CLIENTS AFTER THEY'VE EXITED SHELTER TO STABILIZE THEM IN THEIR NEW HOUSING, WITH A PARTICULAR FOCUS ON ASSISTING WITH SECURING EMPLOYMENT AND/OR OTHER INCOME SOURCE IN ORDER TO REDUCE THE LIKELIHOOD OF THE FAMILY OR INDIVIDUAL RETURNING TO HOMELESSNESS. RAPID RE-HOUSING CASE MANAGERS SEE CLIENTS IN THEIR HOMES AND DEVELOP CASE PLANS TO PREVENT RECIDIVISM.
