Transplant Foundation (the "Foundation") is committed to supporting organ and tissue donation and transplantation, as well as organ and tissue donor families and recipients. This includes the more than 119,970 people awaiting a life-saving organ transplant nationally (more than 5,666 of whom are awaiting transplant in the Foundation's region), and thousands of others who would benefit from life-enhancing tissue transplants. Through its Gift of Life Institute, the Foundation supports research, educational programs, and training seminars in support of organ and tissue donation and transplantation.

	A) Transplant Foundation is committed to supporting the mission of Gift of Life Donor Program through its commitment to -Improve the quality of life of patients awaiting transplantation by maximizing the availability of donor organs and tissues while upholding the highest medical, legal, ethical and fiscal standards through initiatives such as educational and informational programming to the community at large through the special events and clinical trainings supported by Transplant Foundation to the medical community through its Gift of Life Institute, -Work in partnership with the region's hospitals and health care professionals to ensure that the family of every potential donor is offered the opportunity to support organ and tissue donation in a compassionate, timely, informative and caring manner, - Provide educational programs and materials to positively predispose all members of the community to organ and tissue donation so that donation is viewed as a fundamental human responsibility through programming such as Donors Are Heroes Grants, -Serve as a community resource by providing support for families of donors as well as transplant recipients and their families, collaborating with Hearts and Smiles Foundation to support Camp Jeremy, supporting a Sedum Garden for patients and families at A I DuPont Hospital for Children, programs such as the Caregiver Lifeline and scholarships such as the Jessica Beth Schwartz College Scholarship program, along with the development and support of the Gift of Life Family House initiative, and-Serve as a leader in the advancement of organ and tissue donation and transplantation through initiatives such as Gift of Life Institute, including the 2012 addition of the National Transplant Pregnancy Registry and the 2015 establishment of the Donation and Transplantation Grant Program B) In addition to its ongoing community education and grant programs, and the programming through its Gift of Life Institute, Transplant Foundation continues to support Gift of Life Family House, a Ronald McDonald type setting, where families of patients undergoing transplants at the transplant centers in the Philadelphia region will be accommodated near the site of the surgery and for follow-up visits The Foundation supported the planning, design and program development, construction and operations of the Family House C) Transplant Foundation's primary exempt purpose is to support the mission of Gift of Life Donor Program Specifically, Transplant Foundation fulfilled its mission in 2015 through its ongoing support of the Gift of Life Institute, the organization of the Team Philadelphia entry into the Transplant Games of America, the Gift of Life Donor Dash, the 2nd annual Delaware Donor Dash, the Living Donor ceremonies, its establishment of the Donation and Transplantation Grant Program and educational programming through grants issued to schools and houses of worship, and scholarships In addition to the program expenses supporting these initiatives, Transplant Foundation extended support through a grant for the on-going operation of Gift of Life Family House Gift of Life Institute Transplant Foundation fulfills its mission to provide professional education and training through its education and research division, the Gift of Life Institute Transplant Foundation, through its Institute, seeks to advance the science, safety and efficiency of the donation process Transplant Foundation focuses on these objectives because the supply of organs and tissues for transplantation continues to fall short of expectation Currently, there are over 119,000 persons awaiting a life-saving organ transplant in the United States and thousands of others who could benefit from life-enhancing tissue transplants In calendar year 2015, 6,355 people on the waiting list died while awaiting a life-saving organ transplant Although there is no consensus surrounding a solution to the underlying problem of the organ shortage, training, skill development, education, and retention of donation professionals are major concerns Transplant Foundation's educational programming for professionals is grounded on the philosophy that innovation must replace traditional learning in this field and that historically there has been an unnecessary delay between the acquisition of new knowledge and its implementation through clinical practice Transplant Foundation believes a new approach is necessary to underscore the significance of what is learned, to transmit and disseminate what is known, and to benefit from what is collectively achieved In furtherance of the mission, Transplant Foundation through the Gift of Life Institute conducted twenty workshops and/or consulting opportunities in 2015, covering family communication and consent for organ and tissue donation, hospital services staff development, with more than 478 professionals participating in those 2015 trainings The Institute also provided training to 49 donation professionals in Toronto, Canada in its End-Of-Life Conversations with Families of Potential Donors Leading Practices in Offering the Opportunity for Donation which was commissioned by the Canadian Blood Services Additionally, the Institute provided training to 355 donation professionals through its eLearning and virtual classroom initiatives and worked with 40 professionals from five countries to support donation and transplantation initiatives during this time period In total, the Institute has worked with over 39 countries to support the development of responsible and ethical donation and transplantation practices internationally In 2012 Gift of Life Institute expanded its research initiatives and support of transplant recipients when the National Transplantation Pregnancy Registry (NTPR) formally joined the Institute Since 1991, NTPR has tracked and studied the outcomes of thousands of pregnancies in solid organ transplant recipients NTPR is an ongoing study, and the information collected helps thousands of transplant recipients make family planning decisions The NTPR team is comprised of nurses experienced in transplant patient care and trained interviewers, some of whom are transplant recipients themselves In 2015, 12 abstracts were submitted to academic meetings and oral and poster presentations were given at academic meetings In addition, NTPR presented at recipient support groups and transplant centers Six invited journal articles and book chapters were written Transplant Foundation's Donation and Transplantation Grant Program In 2015 the Grant Program was established to advance organ and tissue donation and transplantation, particularly in the Gift of Life donation service area The goal of the Grant Program is to support innovation, quality, and safety in the field of donation and transplantation through scientific research, community programming or alternate approaches to existing processes and protocols Team Philadelphia In 2015, the Foundation continued its sponsorship and coordination, along with Gift of Life Donor Program, of the "Team Philadelphia" entry to the "Transplant Games of America " The Transplant Games are a Special Olympic type program conducted biannually for transplant recipients The purpose of the Transplant Games is to increase awareness that transplantation is successful, to increase public awareness and commitment to organ donation by encouraging people to discuss their feelings about organ donation with their families, to recognize the families who donate the organs and tissues from their loved ones each year, and to provide an event that fosters the successful rehabilitation of all patients who have received organ and tissue transplants The athletes act as torchbearers for the more than 119,970 Americans who are waiting to receive transplants, and their second chance at life due to the critical shortage of donated organs for transplant The Transplant Games are also a celebration of life among the recipients, their families, and the families of donors In 2015, the Foundation began preparations for the 2016 Transplant Games being held in Cleveland, OH June 10-15, 2016 Preparations in 2015 included hosting the first Team Meeting to educate the community and potential team members about the Transplant Games and Team Philadelphia, as well as the success of donation and transplantation
