Beginning in 2014 and continuing in 2015, the UVMC Foundation (UVMCF) has undertaken a major multi-year community health out-reach project in response to Upper Valley Medical Centers and the Miami County Combined Health Districts community health needs assessment. The program is a series of projects designed to combat bullying and address feelings of isolation among school age students, Kindergarten through High School, through the use of kindness and compassion in everyday dealings. The UVMC Foundation (UVMCF) provides program support for cancer patients. In 2015, the UVMCF defrayed the costs of the medical massage/integrative medicine program for cancer patients, providing over 1360 visits, a 139% increase from 2014 to 2015.

In 2015, the UVMC Foundation (UVMCF) continued its dedication to providing scholarships to individuals in our service area pursuing a degree in a health-related field. In addition, the UVMCF also supports Clinical Excellence through scholarships for UVMC staff to attend national conferences/seminars to enhance their clinical expertise.

Temporary endowments are funds in which all or part of the principal may be expended only after the expiration of a stated period of time or occurrence of a specified event, depending on the donor's wishes. Earnings from temporarily restricted endowments can be either unrestricted or restricted. The UVMCF uses the temporarily restricted endowments for the intended purpose set up by the donor, only after the period of time or specified event set by the donor has been met.
