- **A plan for evaluating, reporting and disseminating the results of the project;**
- **Qualifications of those who will be engaged in the project;**
- **Legal and tax status – include a copy of the IRS letter of designation;**
- **Brief description of anticipated achievements or outcomes;**
- **Information such as mailing address and the name and phone number of the contact person;**
- **A current list of board members and affiliations;**
- **Population and geographic area served; and,**
- **Period of time for which funds are requested;**

While there are no deadlines for requests for funds from the Huntington Foundation, Huntington staff will review the initial letter of inquiry within four months of receipt of the request. However, please recognize the Huntington Foundation is able to fund only a very small percentage of the requests it receives. Many requests are declined not because they lack merit, but because they do not match the current programming guidelines and interests of the Huntington Foundation.

A full proposal and additional materials may be requested at a later time. Please recognize a request to submit a full proposal is not an indication of the Foundation's intention or commitment to award a gift. Also, please do not send the following unless specifically requested: invoices; examples of past projects; IRS information; staff lists/job descriptions, resumes, or staff bios; videos; cassettes; or, books.

Please note, when we have received a full proposal for those projects that will receive Huntington Foundation support, additional consideration will be given to the following questions:

- How does the project fit within the Foundation's overall program priorities?
- Does the project address a specific community need? Is there a funding gap or is there a critical opportunity that needs to be addressed?
- Does the project propose a creative or innovative approach/solution?
