Meals-on-Wheels provides nounshing food and a daily visit to homebound, older adults and individuals living with a medical challenge and/or disability 365 days a year Meal options include hot, cold, frozen, specialty diet, kosher, vegetarian, pureed and mechanical soft The Meals-on-Wheels program delivers approximately 5,000 meals a day, and also provides meals for children in day care and after-school programs In 2015, volunteers and staff delivered 897,319 meals to clients in Franklin, Madison, Marion, Champaign and Logan counties In 2015, Meals-for-Kids provided 170,463 meals to predominately low-income and at-risk children at 21 sites in central Ohio Congregate Dining Centers provide meals for older adults and individuals living with a medical challenge and/or disability at community dining centers and restaurants in 36 locations across central Ohio, including culturally diverse meals at 9 Asian and Somali restaurants Transportation is available to most locations Dining centers offer socialization, enriching programming and a nutritious meal with the purpose of promoting successful aging among central Ohioans, which is defined as the avoidance of disease and disability, maintenance of high cognitive and physical functioning and engagement with life In 2015, the program served 138,507 meals to 3,899 clients

Wellness Centers provide health care services in community wellness centers located throughout Franklin County in areas where the population is underserved with limited financial resources and/or access to health care Services include, but are not limited to, health assessments, skilled nursing care, assistance with medication management and screening tests with a focus on health education, disease prevention and chronic disease management Registered Dietitians provide medical nutrtion therapy, weight management programs, diabetes self-management, and a wide variety of nutrition education programs In 2015, the program served 1,403 clients through 4,968 visits to wellness and foot care centers Visiting Nurses provide health care linkage services to assist clients with managing their health, nutrition and well-being In 2015, the program served 373 clients, completing 320 successful linkages The wellness team also provides educational programming and health care services in the corporate setting The Catch the Wellness Spirt Wellness Program provides on-site services as well as personal coaching at the worksite with registered nurses and dietitians and international travel health clinics which include a comprehensive pre-travel assessment and required vaccines Health fairs for community organizations and businesses are a recent addition to the wellness program In 2015,the Corporate Wellness program served 29 corporations

The Columbus Cancer Clinic, a Medicare certified service, provides cancer prevention and early detection education, head-to-toe cancer screenings, examinations and mammograms The Clinic's mammography unit is the only truly mobile unit in central Ohio with its ability to be transported into facilities such as community centers and churches The program provides home care support services to clients living with active cancer at no cost These services include, but are not limited to, assistance with medical supplies and equipment, medication, transportation to and from cancer-related medical appointments, pantry items, wigs and breast prostheses, nutrntional supplements and housing and/or utility bills in emergency situations, often keeping clients out of homelessness In 2015, the program served 2,428 clients, providing 1,386 mammograms, 481 head-to-toe cancer screenings and 561 clients with home care support services 22% of all The Columbus Cancer Clinic clients are age 65 or older, 68% have an annual income of less than \$20,000, 88% are female, and 55% are minority The Columbus Cancer Clinic began in 1921 and is the oldest free cancer clinic in the United States The Agency merged with LifeCare Alliance in 2005

The committee is comprised of fourteen (14) individuals that includes the Board Treasurer and Assistant Treasurer who possess the knowledge and understanding of the agency's operations, finances, and the non-profit environment.
