In 2015 we shipped and delivered over 12,000 sandals for women at risk in the slums of India. At least 200 women, who face domestic violence attacks, signed up for counseling through our more than 25 footwear clinics. We partnered to put on the Vizag Cityfest with over 34,500 in attendance. During the campaign, we trained over 1,000 believers in basic disciple-making. We collected 1,920 Response Cards and 200 young adults attended discipleship meetings afterwards called After Parties. Additionally, we clothed the feet of over 2,500 children in Vizag and encouraged over 10,000 college and younger school children through character and hope-focused messages presented by performers and speakers. We also laid the ground work to start Celebrate Recovery Training in India which started in January 2016. Overall, we shared the Gospel with 65,826 people, recorded 3,482 responses and trained 1,571 believers in discipleship and evangelism.
