Some groups pay usage fees and groups such as the 4-H program, the local high school rodeo club, etc do not pay usage fees. The general public can use the arena as individuals, without charge, when it is not scheduled for other events. This usage usually falls into the category of recreational horseback riding, horse training exercises (such as preparing for rodeo-type events and barrel racing) and for preparation for horse and other livestock shows. The county fair uses these grounds for the annual week long fair.
