AT LA JOLLA INSTITUTE, OUR SCIENTISTS FOCUS ON UNDERSTANDING HOW THE IMMUNE SYSTEM WORKS IN ORDER TO PROMOTE HUMAN HEALTH AND PREVENT DISEASE. OUR DISCOVERIES APPLY TO MANY DISEASES, RANGING FROM DIABETES TO HEART DISEASE, INFECTIOUS DISEASES TO CANCER.

THE LA JOLLA INSTITUTE FOR ALLERGY AND IMMUNOLOGY ("LJI") IS A PRIVATE, NONPROFIT MEDICAL RESEARCH ORGANIZATION THAT IS RECOGNIZED AS A WORLD LEADER IN COMPREHENSIVE RESEARCH DEDICATED TO UNDERSTANDING THE INTRICACIES AND POWER OF THE IMMUNE SYSTEM AND APPLYING THAT KNOWLEDGE TOWARD ITS GOAL OF LIFE WITHOUT DISEASE. THE INSTITUTE IS HOME TO 23 INDEPENDENT LABORATORIES, EACH OPERATED BY A LEADING SCIENTIST HANDPICKED FOR HER CREATIVITY AND PIONEERING SPIRIT. EACH OF THESE LABS IS DEDICATED TO UNDERSTANDING THE FAR-REACHING INFLUENCE OF THE IMMUNE SYSTEM AND TO TRAINING TO THE NEXT GENERATION OF SCIENTISTS, TO PROMOTE HUMAN HEALTH AND PREVENT A WIDE RANGE OF DISEASES. THE INSTITUTE WAS RECENTLY RANKED AMONG THE TOP FIVE ORGANIZATIONS WITH THE GREATEST RESEARCH IMPACT IN IMMUNOLOGY WORLDWIDE BY THE RATING AGENCY THOMSON-REUTERS. IN ADDITION, THREE OF ITS SCIENTISTS ARE AMONG THE MOST HIGHLY CITED IMMUNOLOGISTS IN THE WORLD-A DISTINCTION HELD BY LESS THAN HALF OF ONE PERCENT OF ALL PUBLISHING SCIENTISTS. 2015 NOTABLE RESEARCH RESULTS IN 2015, LJI RESEARCH TEAMS MADE DISCOVERIES MERITING PUBLICATION IN LEADING PEER-REVIEWED SCIENTIFIC JOURNALS - 156 PAPERS IN ALL, AN ALMOST 10 PERCENT INCREASE FROM THE YEAR BEFORE. NO FEWER THAN 36 ORIGINAL RESEARCH PAPERS APPEARED IN HIGH IMPACT JOURNALS, WHICH IS A MEASURE OF THE RESEARCH'S PIONEERING NATURE AND INFLUENCE. TOGETHER, THEY ILLUSTRATE THE RANGE AND POWER OF IMMUNOLOGY RESEARCH AND ITS IMPACT ON A BROAD GROUP OF HUMAN HEALTH ISSUES. SOME OF THE HIGHLIGHTS AMONG PAPERS PUBLISHED IN 2015 INCLUDE THE CROTTY LAB IDENTIFIED A PAIR OF SIGNALS THAT GOVERN THE FATE OF T FOLLICULAR HELPER CELLS. FOLLICULAR HELPER T CELLS (TFH CELLS), A RARE TYPE OF IMMUNE CELL THAT IS ESSENTIAL FOR INDUCING A STRONG AND LASTING ANTIBODY RESPONSE TO VIRUSES AND OTHER MICROBES, HAVE GARNERED INTENSE INTEREST IN RECENT YEARS BUT THE MOLECULAR SIGNALS THAT DRIVE THEIR DIFFERENTIATION HAD REMAINED UNCLEAR. THE RESEARCHERS FINDING HOLDS GREAT PROMISE FOR IMPROVED VACCINE DESIGN AND MAY LEAD TO NEW TREATMENTS FOR IMMUNE DISORDERS AND POSSIBLY EVEN CANCER. (PUBLISHED IN NATURE IMMUNOLOGY, JULY 2016) THE SETTE LAB IDENTIFIED A UNIQUE SUBSET OF HELPER T CELLS THAT APPEARS TO PLAY AN IMPORTANT PROTECTIVE ROLE IN CONTROLLING DENGUE VIRUS INFECTIONS. THE FINDINGS SUPPORT THE NOTION THAT A SUCCESSFUL DENGUE VACCINE NEEDS TO INDUCE A STRONG T CELL RESPONSE IN ADDITION TO HIGH ANTIBODY TITERS, THE YARDSTICK AGAINST WHICH THE PROMISE OF VACCINE CANDIDATES HAS TRADITIONALLY BEEN MEASURED. (PUBLISHED IN THE PROCEEDINGS OF THE NATIONAL ACADEMY OF SCIENCES, AUGUST 2015) THE HEDRICK LAB DISCOVERED THAT A SUBPOPULATION OF WHITE BLOOD CELLS GUARDS AGAINST TUMOR LUNG METASTASIS, MAKING IT THE FIRST STUDY TO SHOW THAT THAT PATROLLING MONOCYTES DIRECTLY BLOCK LUNG METASTASIS, FINDINGS THAT COULD SUGGEST FUTURE IMMUNOTHERAPIES TO TREAT AN EXTRAORDINARILY LETHAL CANCER. HEDRICK AND HER TEAM SUCCESSFULLY TRACKED THE WANDERINGS OF THESE CELLS IN THE LUNG VASCULATURE, FILMED THEM PURSUING INVADING TUMOR CELLS, AND EMPLOYED A MOUSE MODEL THAT THEY DEVELOPED TO DEMONSTRATE HOW EFFECTIVE THIS PURSUIT IS IN A LIVING ANIMAL. (PUBLISHED IN SCIENCE, OCTOBER 2016) THE RAO LAB SHOWED THAT TET PROTEINS PLAY AN INTEGRAL PART IN MAINTAINING GENOME INTEGRITY. MEMBERS OF THE TET (SHORT FOR TEN-ELEVEN TRANSLOCATION) FAMILY HAVE BEEN KNOWN TO FUNCTION AS TUMOR SUPPRESSORS FOR MANY YEARS, BUT HOW THEY KEEP A LID ON THE UNCONTROLLED CELL PROLIFERATION OF CANCER CELLS HAD REMAINED UNCERTAIN. NOW, RAO AND HER DEMONSTRATE THAT TET PROTEINS ARE REQUIRED TO MAINTAIN GENOME INSTABILITY AND COLLECTIVELY CONSTITUTE A MAJOR CLASS OF TUMOR SUPPRESSORS. (PUBLISHED IN NATURE COMMUNICATIONS, DECEMBER 2015) TESTIFYING TO THE HIGH LEVEL OF ACHIEVEMENT TAKING PLACE AT THE INSTITUTE ARE THE AWARDS AND HONORS INSTITUTE SCIENTISTS RECEIVED IN 2015. DR. MITCHELL KRONENBERG, PRESIDENT AND CHIEF SCIENTIFIC OFFICER OF THE LA JOLLA INSTITUTE FOR ALLERGY AND IMMUNOLOGY, HAS BEEN NAMED A FELLOW OF THE AMERICAN ASSOCIATION FOR THE ADVANCEMENT OF SCIENCE (AAAS). ELECTION AS A AAAS FELLOW IS AN HONOR BESTOWED UPON AAAS MEMBERS BY THEIR PEERS FOR SCIENTIFICALLY OR SOCIALLY DISTINGUISHED EFFORTS TO ADVANCE SCIENCE OR ITS APPLICATIONS. DR. KRONENBERG WAS RECOGNIZED FOR HIS DISTINGUISHED CONTRIBUTIONS TO UNDERSTANDING T LYMPHOCYTE BIOLOGY, PARTICULARLY ANALYSIS OF ANTI-BACTERIAL IMMUNE RESPONSES, NKT CELLS, AND TISSUE RESIDENT T CELLS IN THE INTESTINAL MUCOSA. IN ADDITION, IN 2015 THE INSTITUTE SAW CONTINUED ADVANCEMENT OF ITS RESEARCH DISCOVERIES BY INDUSTRY PARTNERS IN THE PHARMACEUTICAL PIPELINE, INCLUDING THERAPIES FOR SICKLE CELL ANEMIA, AS WELL AS FOR PSORIASIS AND ORGAN TRANSPLANT ENTERING PHASE II CLINICAL TRIALS. THE INSTITUTE ALSO FORGED A NUMBER OF NEW RESEARCH COLLABORATIONS WITH BOTH LARGE AND EMERGING PHARMACEUTICAL COMPANIES TOWARDS THE DEVELOPMENT OF NEW THERAPEUTICS AND DIAGNOSTICS IN THE AREAS OF INFECTIOUS DISEASE, ALLERGY AND ASTHMA, AUTOIMMUNITY, AND ONCOLOGY. THESE RELATIONSHIPS GREATLY AID THE TRANSLATION OF LJI EXPERTISE AND RESEARCH FINDINGS TOWARD THE DETECTION, PREVENTION, AND TREATMENT OF A GREAT BREADTH OF HUMAN DISEASES. COMPETITIVE RESEARCH GRANT FUNDING & RESEARCH AWARDS & DISTINCTIONSTHE ABILITY OF LA JOLLA INSTITUTE SCIENTISTS TO RECEIVE INCREASING NUMBERS OF COMPETITIVELY AWARDED RESEARCH GRANTS ATTESTS TO THE HIGH LEVEL OF RESEARCH PRODUCTIVITY PRESENT AT THE INSTITUTE. DURING 2015, LJI SCIENTISTS WORKED WITH THE SUPPORT OF 121 GRANTS AND FELLOWSHIPS FROM THE NATIONAL INSTITUTES OF HEALTH, THE INTERNATIONAL AIDS VACCINE INITIATIVE, THE JUVENILE DIABETES RESEARCH FOUNDATION, THE LIFE SCIENCES RESEARCH FOUNDATION, THE PEW CHARITABLE TRUST, THE JAN COFFIN CHILDS MEMORIAL FUND FOR MEDICAL RESEARCH, THE AMERICAN HEART ASSOCIATION, THE AMERICAN DIABETES ASSOCIATION, THE CANCER RESEARCH INSTITUTE, THE MELANOMA RESEARCH ALLIANCE FOUNDATION, THE CROHN'S AND COLITIS FOUNDATION OF AMERICA, THE OKLAHOMA MEDICAL RESEARCH FOUNDATION, THE AMERICAN ASSOCIATION FOR CANCER RESEARCH, THE NATIONAL SCIENCE FOUNDATION, THE ARTHRITIS NATIONAL RESEARCH FOUNDATION, THE TRASHER RESEARCH FUND AND THE A.P. GIANNINI. NOTABLY, IN 2015, AN TEAM LED BY LJI INVESTIGATOR ALESSANDRO SETTE, PH.D., WAS SELECTED AS ONE OF FOUR RECIPIENTS OF A HUMAN IMMUNE PROFILING CONSORTIUM (HIPC) GRANT TOTALING \$ 18 MILLION. WITH THIS PRESTIGIOUS GRANT, THE LJI TEAM WILL CHARACTERIZE THE IMMUNE RESPONSE TO DENGUE VIRUS (DENV) AND MYCOBACTERIUM TUBERCULOSIS (TB), BOTH OF WHICH REPRESENT MAJOR GLOBAL HEALTH CHALLENGES. THE PRESTIGIOUS HIPC GRANT AWARD IS A TESTAMENT TO THE CALIBER OF LJI SCIENTISTS AND VALIDATES THEIR SUSTAINED EFFORTS TO FACILITATE VACCINE DEVELOPMENT AND PROVIDES THEM WITH THE OPPORTUNITY TO UNLEASH THE FULL FORCE OF THEIR COLLECTIVE SCIENTIFIC EXPERTISE AND TECHNOLOGICAL CAPABILITIES TO TRACE THE ELEMENTS THAT MAKE UP AN EFFECTIVE IMMUNE RESPONSE. WITH NEW AND RECURRING GRANT SUPPORT, THE INSTITUTE RECEIVED MORE THAN \$42 MILLION IN RESEARCH FUNDING IN 2015, WHICH IS SUPPLEMENTED BY CORPORATE FUNDING SOURCES AS WELL AS PHILANTHROPIC SUPPORT.
