StandUp for Kids' Outreach Services for the 2015 year included Street Outreach, Apartment Support, Outreach Centers, Educational Classes and Mentoring Programs. These programs provided homeless, street kids and at-risk youth with comfort items (food, clothing, blankets, etc.), vital information regarding available resources to meet their needs, housing for over 350 kids, educational services for over 850 kids, employment, medical, ID/birth certificate services for approximately 280 youth and other support services. The nine (9) outreach/drop-in centers are designed to provide a safe and protective environment for homeless and at-risk kids. Through December 2015, StandUp for Kids was able to assist over 20,000 youths in our Outreach centers.
