In perpetuity sponsorship of annual Tibetan Buddhist Nyingma World Peace Ceremonies at Bodhgaya INDIA, including one-way travel reimbursement for monastic participants; ceremony offerings of butter lamps, candles, tsog (food), flowers; daily food offerings to the local poor. Head Lama of TNMC Yeshe De Project books and art are freely given to monastic and lay practitioners. Under section 3 of foundation documents, the trustor may designate any alternative location to perform the religious observances described in the trust

Transfer to Head Lama of TNMC for further transfer to India, funds for the Jan 2015 26th World Peace Ceremony. Over the course of 10 days, a total of \$145,478 was given to as many as 7,084 monastics/day, one-way travel reimbursements. Text distribution expenses were \$5,654 including labor to unload cargo containers of books. 100,000 butter lamps were offered daily, \$4,728. Flowers, beggars' food offerings, butter lamp offerings on the last day, morning temple offerings \$8,594. Helper monks' food, lodging & transportation, \$4,032 Admin. Lodging and food for 21 people assisting ceremony, internet and phone, car rental & food: \$18,137. All of these expenses were according to pre-approved budget under Head Lama of TNMC

In 2014, TNMC sponsored a Tibet World Peace ceremony at Samath International Nyingma Institute. 2000 Nyingma Lamas attended. In Jan 2015, funds were sent to INDIA for further Tibet World Peace ceremonies at Samath International Nyingma Institute. About 2500 Nyingma Lamas attended after the Bodhgaya ceremony above. Busses were hired to transport the monastics from Bodhgaya to Samath. The ceremony lasted 5 days. Daily offerings included tsog (food), tea, butter lamps, flowers, and tents for the meals and overnight accommodations for the monks; a small offering in rupees was also given to each monastic. These funds also supported a similar Tibet World Peace Ceremony in 2016

In Dec 2015, \$171,000 was sent under the direction of TNMC to INDIA for the 27th Bodhgaya annual World Peace Ceremony to be held in Jan of 2016. \$156,000 was budgeted for ceremony expenses and an additional \$15,000 was for travel expenses for TNMC staff to supervise the whole ceremony set-up, administration, and text distribution. The numbers of attendees and offerings was similar to the previous Jan 2015 ceremony as detailed above. In total, over 10,000 monastics and lay people attended the ceremony.

Head Lama of the Tibetan Nyingma Meditation Center (TNMC) is the supported organization for the Bodhgaya Religious Trust. The assets of the Bodhgaya Trust are in a Vanguard account. The Vanguard account manager met with members of the Board several times during the year to discuss the investment policies and performance of the account. These members included the Head Lama and President of TNMC who is also President of the Board of the Bodhgaya Trust. Additionally, monthly statements are sent to the treasurer of the Trust as well as to the office of the Head Lama of TNMC. All investment policies and asset allocations are approved by this overlapping board with Head Lama of TNMC. Head Lama meets with members of the Board yearly and establishes a budget for the ceremony. At the end of the yearly ceremony, a report is made reconciling the budget with the actual expenditures of that year's ceremony. Any leftover funds are accounted for and deposited with the ceremony committee of monasteries in India for use the following year. Head Lama of TNMC oversees these budgets and reports.

The Bodhgaya Religious Trust is engaged in a direct furtherance activity for Head Lama of the Tibetan Nyingma Meditation Center, a church. This Trust holds the endowment funds for the furtherance of the annual Nyingma Bodhgaya Peace Ceremony so that the ceremonies may go on in perpetuity. As noted above, investment and disbursement policies are made in collaboration with TNMC. The church directs activities of the Bodhgaya Trust according to the founding principles of the Trust which is an integrated auxiliary of the church.
