Provided 26 water projects within the state of Andhra Pradesh resulting in an estimated impact of clean water to 15,000 people. In addition to drilling new bore wells and installing either hand pumps or submersible pump motors and tanks, emergency relief water camps were implemented during a period of intense heat in 3 different locations in and around Tuni, AP. Funding was also provided for programs benefiting those with HIV/Aids and leprosy and other physical handicaps. Assistance for 6 medical camps was also provided benefiting on average 300 - 400 men, women and children for each camp.

4b (Code:) (Expenses \$ 89,552.00 including grants of \$ 65,694.00) (Revenue \$ 1,780.00)

Provided 22 water projects in North India; Gujarat, West Bengal and Odisha resulting in an estimated impact of 11,000 people. In addition to drilling new bore wells and installing either hand pumps or submersible pump motors and tanks. Additionally provided funding for a sewing center which will help provided training and livelihood to 25 women each month and help secure their future upon graduating from the program. Funds were also provided to our Odisha partner for further improvements to the property for better self-sustainability.

Provided 14 water projects in Southern India; Tamil Nadu (10), Telangana (2), Karnataka (2). The estimated impact of these projects is 10,000 men, women and children. A digital learning center was also funded in Telangana which impacts 25 children ages 3 - 6.
