Bridgeway House provides comprehensive evaluations and in-home therapeutic treatment programs for individuals affected by autism. The proposed treatments typically involve individual counseling and often include travel time. The cost of these services are out of the reach for most of our clients and we use a sliding scale in an effort to provide our services to as many families as possible. This is often difficult and challenging work, yet we believe early intensive behavior therapies and whole family involvement offer the brightest possible outcomes for our clients.

Bridgeway House offers a comprehensive website with autism FAQs, an event and class calendar and links to other resources on the web. The website connects families in need of assistance with existing community resources using the internet. The website is often the first contact our clients have with our services, and provides anonymous information regarding autism and related services to the community at large at no cost to the user.

Bridgeway House supports a telephone message center and an outreach support group to answer questions both by phone and in person.
