	Legacy Charities is involved in facilitating programs that bring indigent orphaned infants, toddlers, young children with medical needs, and blind children into foster care. Legacy Charities facilitates and assists with care of the orphans in appropriate facilities, provides nutritional care, arranges medical care and surgical procedures as needed. Legacy Charities worked on several major projects in 2015. New Day Foster Home: 32 children were adopted, 39 surgeries were provided. Additional Programs Beijing Home: This is a home for long term care. Children in need of surgery arrive to get the surgery they need. Following surgery they are placed in a foster family unless their medical condition requires a doctor's close care, then they remain in the home. Children here will stay until they are adopted. Legacy Charities assists with the care of these children, and helps to facilitate the necessary surgeries. Formula Project: Supplies infant milk powder to partner orphanages for infant until they turn one. We monitor the children's growth progress and provide additional nutritional supplements and any medical care needed. An average of 47 children benefited from this project each month in 2015. Beijing Foster Program: This is a foster parent program for indigent children waiting to be adopted. A total of 41 children were cared for between the Beijing Home and Beijing Foster Program during 2015. In addition, a Critical Care Unit has been opened to provide care to our most medically fragile children. This unit housed 4 children in 2015. New Day South Foster Home: Located in Zhongshan, Southern China, this facility and the addition of a new facility has allowed us to increase our care to assist 20 or more children. We average caring for 12 children in this facility. New Day South has also begun providing temporary medical care for children from other orphanages, so that they are able to recover from surgery prior to going back to their home orphanage. New Day North Foster Home: Work continues in Inner Mongolia, bringing children to Beijing for life saving surgeries and life changing therapy. In 2015 there were a total of 13 children under care in New Day Foster Home. New Day Foster Home North has also begun a Special Needs Care & Training Center, which is providing care for several special needs children, and is providing training for local staff.
