MARY'S MEALS USA PROVIDES GRANTS TO MARY'S MEALS INTERNATIONAL TO FUND ITS SCHOOL FEEDING PROGRAMS, WHICH PROVIDE WARM, NUTRITIOUS MEALS TO OVER ONE MILLION VULNERABLE CHILDREN IN SOME OF THE WORLD'S POOREST COMMUNITIES, EVERY SCHOOL DAY SCHOOL MEALS INCREASE ACCESS, PARTICIPATION AND PROGRESSION WITHIN PRIMARY EDUCATION, RESULTING IN MEASURABLE CHANGE IN THE COMMUNITIES WITH WHICH MARY'S MEALS PARTNERS IN 2015, MMUSA'S THREE LARGEST PROGRAM GRANTS SUPPORTED MARY'S MEALS INTERNATIONAL'S SCHOOL FEEDING PROGRAMS IN MALAWI (\$1,378,465), LIBERIA (\$864,722) AND ZAMBIA (\$46,953) IN MALAWI, MARY'S MEALS IS NOW FEEDING A TOTAL OF 779,617 CHILDREN AT 600 PRIMARY SCHOOLS AND 45 UNDER SIX CENTERS EVERY SCHOOL DAY THIS REPRESENTS OVER 27% OF ALL PRIMARY SCHOOL AGED CHILDREN IN THE COUNTRY MEALS ARE PROVIDED FREE OF CHARGE TO EVERY CHILD ENROLLED IN THE SCHOOLS WE SERVE AND THIS HAS AN ENORMOUS IMPACT IN ENABLING MARGINALIZED CHILDREN TO ATTEND SCHOOL, PARTICULARLY GIRLS GIRLS GROWING UP IN EXTREME POVERTY IN MALAWI FACE MANY CHALLENGES THERE IS RELATIVELY LOW SUPPORT FOR GIRLS' EDUCATION ACROSS THE COUNTRY AND GIRLS ARE OFTEN REQUIRED TO HELP THEIR FAMILIES AT HOME, UNDERTAKE MENIAL UNSKILLED WORK TO CONTRIBUTE TO THE DOMESTIC ECONOMY, OR TO MARRY EARLY RATHER THAN COMPLETE THEIR EDUCATION HOWEVER, MARY'S MEALS HAS A PROVEN TRACK RECORD OF PROMOTING GENDER EQUALITY AND IS REVERSING THIS TREND IN THE SCHOOLS WE SUPPORT OUR INCLUSIVE APPROACH MEANS THAT A NUTRITIOUS DAILY MEAL IS PROVIDED TO EVERY CHILD AT SCHOOL AND GIRLS CURRENTLY REPRESENT 50 5 PER CENT OF ALL CHILDREN ENROLLED IN THE SCHOOLS IN OUR MALAWI PROGRAM MARY'S MEALS IS CURRENTLY PROVIDING A NUTRITIOUS MEAL TO 130,556 CHILDREN IN 398 SCHOOLS AND NURSERIES ACROSS FOUR COUNTIES IN WESTERN LIBERIA (BOMI, GRAND CAPE MOUNT, GBARPOLU AND MONTSEERRADO) FOLLOWING THE END OF OUR EMERGENCY RESPONSE DURING THE DEVASTATING OUTBREAK OF EBOLAVIRUS DISEASE (EVD), OUR SCHOOL FEEDING PROGRAM RESUMED IN LIBERIA IN MARCH 2015 AND OUR RECORDS SHOW THAT SCHOOL ATTENDANCE RATES ARE NOW VERY HIGH THE NUTRITIOUS FOOD PROVIDED BY MARY'S MEALS CONTINUES TO ACT AS A VITAL LIFELINE BY PROVIDING ONE, NUTRITIOUS, HOT MEAL TO CHILDREN IN LIBERIA EVERY SCHOOL DAY, MARY'S MEALS CONTINUES TO BRING HOPE OUR SCHOOL FEEDING PROGRAM IS REDUCING CLASSROOM HUNGER AND IS GIVING CHILDREN THE CHANCE OF A BRIGHTER FUTURE BY DRAWING THEM INTO SCHOOL TO RECEIVE AN EDUCATION IN ZAMBIA, THE COUNTRY SUFFERS FROM HIGH RATES OF MALNUTRITION, POVERTY AND FOOD INSECURITY MARY'S MEALS OPERATES IN CHIPATA, CAPITAL OF THE COUNTRY'S EASTERN PROVINCES AND IS NOW PROVIDING 42,914 CHILDREN A MEAL IN SCHOOL EACH SCHOOL DAY IN 2015, THE NUMBER OF CHILDREN BEING FED BY MARY'S MEALS INTERNATIONAL INCREASED TO FROM 989,791 TO 1,101,206
