Energy Assistance and Weatherization The Home Weatherization Assistance Program is a federally funded low-income residential energy efficiency program The program reduces low-income households' energy use, thus creating more affordable housing for those in most need Services include attic, wall and basement insulation, blower-door-guided air leakage reduction, heating system repairs or replacements, and health and safety testing and inspections All measures are provided based on an on-site energy audit and on cost-effective guidelines developed using the NEAT computerized energy audit Individualized client education is an important component of the program The Home Energy Assistance Program is a federally funded program designed to help low-income Ohioans meet the high cost of home heating In 2015 106 homes were weatherized
