In 2015, ACCESS's emergency shelter served 382 residents-190 women and 192 children. Approximately 38,000 meals and snacks were served and approximately 12,700 nights of shelter were provided resulting in an average stay of 30 days per resident.

In 2015, ACCESS's Step II transitional shelter served 18 single, homeless adult females over the age of 18. A total of 6,570 bed nights were provided resulting in an average stay of 365 days per resident. 8,928 meals and snacks were served. Step II had 15 graduates in 2015.
