Additionally, in 2015, ILASS-Americas provided 4 students travel awards to attend the International Conference on Liquid Atomization and Spray Systems (ICLASS) in Tainan, Taiwan. Each travel award was \$2000 and documented travel expenses exceeded the award for each recipient.  $\$1000 \text{ (Best Student Paper)} + 4 * \$2000 \text{ (ICLASS Travel Awards)} = \$9000$
