THE HUNGER NETWORK OF GREATER CLEVELAND IS INCORPORATED UNDER THE LAWS OF OHIO AS A NOT-FOR-PROFIT CORPORATION. THE PRIMARY FUNCTION OF THE ORGANIZATION IS TO REDUCE HUNGER BY PROVIDING NUTRITIONALLY BALANCED MEALS IN THE FORM OF GROCERIES OR PREPARED MEALS TO BETWEEN 47,000 AND 60,000 PEOPLE PER MONTH INCLUDING APPROXIMATELY 13,000 CHILDREN. THE HUNGER NETWORK OF GREATER CLEVELAND OPERATES IN AN ORGANIZED SYSTEM OF 85 PANTRIES AND HOT MEAL PROGRAMS WHICH ARE STAFFED BY VOLUNTEERS AND OPERATED BY THE ORGANIZATION. 9 STAFF MEMBERS AND 1,800 VOLUNTEERS CARRY-OUT THE ORGANIZATION'S MISSION. THE ORGANIZATION IS DESIGNED TO LEVERAGE LIMITED RESOURCES TO ENSURE THOSE IN NEED ARE SERVED BY ESTABLISHING MINIMUM STANDARDS AND REDUCING POTENTIAL CONFUSION AND DUPLICATION THROUGH TRAINING AND A COORDINATED APPROACH TO SERVICE. THE ORGANIZATION SECURES AND DISTRIBUTES FREE AND REDUCED COST FOOD TO NEIGHBORS IN CUYAHOGA COUNTY AT 85 HUNGER CENTERS AT EITHER FOOD PANTRIES OR HOT MEAL SITES. THE ORGANIZATION PROVIDES CONNECTIONS TO HEALTH AND OTHER COMMUNITY RESOURCES THROUGH ITS STAY WELL PROJECT. THE GOAL OF THE STAY WELL PROJECT IS TO BRIDGE THE GAP BETWEEN HEALTH AND HUNGER THROUGH HEALTH SCREENINGS AND EDUCATION. CLIENTS CAN HAVE HEIGHT, WEIGHT, BLOOD PRESSURE, TOTAL CHOLESTEROL AND BLOOD GLUCOSE MEASURED. CLIENTS ARE THEN COUNSELED ABOUT THEIR RESULTS BY PHARMACY, NUTRITION, MEDICAL AND PHYSICIAN ASSISTANT STUDENTS AND ARE GIVEN EDUCATION MATERIALS THAT ARE WRITTEN AT A FIFTH GRADE READING LEVEL. OUR STAY WELL PROJECT PARTNERS INCLUDE UNIVERSITY HOSPITAL'S DEPARTMENT OF FAMILY MEDICINE AND COMMUNITY HEALTH, CASE WESTERN RESERVE UNIVERSITY SCHOOL OF MEDICINE, CARMELLA ROSE HEALTH FOUNDATION, MIAMI JACOBS COLLEGE, BALDWIN COLLEGE AND CARE ALLIANCE. IN 2015, 6,800 PEOPLE PARTICIPATED IN STAY WELL PROJECT EVENTS AND OF THOSE 1,638 TOOK ADVANTAGE OF THE HEALTH SCREENINGS MENTIONED ABOVE. PATIENT NAVIGATORS ASSIST CLIENTS THAT NEED A MEDICAL HOME OR NEED ASSISTANCE IN ENROLLING IN MEDICARE, MEDICAID OR SNAP PROGRAMS. EACH EVENT HAS HEALTHY FOOD DEMONSTRATIONS, RECIPES USING FOOD PANTRY ITEMS, AND SPEAKERS ON THE TOPICS RELATED TO HEALTHY LIFESTYLE AND EATING.
