2,000 DAYS PLEDGE - THE 2,000 DAYS PLEDGE IS AN EDUCATIONAL PROMISE MADE BY PARENTS AND TEACHERS TO WORK TOGETHER TO ENSURE THAT EVERY CHILD IS READY FOR KINDERGARTEN AND ON THE PATH FOR HIGH SCHOOL GRADUATION AND BEYOND. CREATED BY THE CENTERS FOR FAMILIES AND CHILDREN, THE 2,000 DAYS PLEDGE WAS DESIGNED TO CREATE OPPORTUNITIES AND PROVIDE TOOLS FOR ALL PARENTS TO SUPPORT THE SOCIAL, EMOTIONAL AND ACADEMIC DEVELOPMENT OF THEIR CHILD. THEY RECOGNIZE THE BARRIERS THEIR TARGET POPULATION FACES BUT BELIEVE THAT ALL PARENTS CAN FIND MEANINGFUL WAYS TO CHAMPION THEIR CHILD IF THEY HAVE THE RIGHT SUPPORT, TOOLS AND FOLLOW-UP. THE LIFE COACHES PROVIDE STUDENT SUPPORT IN THE AREAS OF ACADEMICS, BEHAVIOR, ATTENDANCE AND SOCIAL-EMOTIONAL DEVELOPMENT. EACH LIFE COACH WORKS WITH APPROXIMATELY 25 STUDENTS FROM THEIR FRESHMAN YEAR THROUGH GRADUATION. THE LIFE COACHES SERVE AS A LINK BETWEEN HOME AND SCHOOL AND HELP ENSURE THAT THE STUDENTS ARE ON TRACK WITH THEIR ATTENDANCE, ACADEMICS AND POSITIVE BEHAVIOR. THESE POSITIVE ROLE MODELS PROVIDE DEDICATED SUPPORT 24 HOURS PER DAY, SEVEN DAYS PER WEEK. DUE TO THE STRUCTURE AND THEIR SUPPORT, LIFE COACHES HELP IMPACT STUDENT ACHIEVEMENT AND GRADUATION RATES BY HELPING YOUNG MEN REALIZE THE VALUE OF THEIR EDUCATION. RESULTS FROM 2014 INCLUDE A 93% GRADUATION RATE AND 100% PROMOTION RATE IN 9TH-11TH GRADES.

GET TO SCHOOL, YOU CAN MAKE IT - THIS PAST SCHOOL YEAR, THE CLEVELAND METROPOLITAN SCHOOL DISTRICT LAUNCHED AN ABSENCE REDUCTION CAMPAIGN CALLED "GET TO SCHOOL, YOU CAN MAKE IT!" WHICH WORKS TO REMOVE THE BARRIERS OF STUDENTS BEING CHRONICALLY ABSENT FROM SCHOOL. THE CLEVELAND BROWNS FOUNDATION IS THE SIGNATURE PARTNER FOR THE CAMPAIGN, WORKING HAND IN HAND WITH THE DISTRICT. STUDIES SHOW THAT FOR CMSD STUDENTS, MISSING EVEN 10 DAYS OF SCHOOL HAS A SIGNIFICANT NEGATIVE IMPACT ON TEST SCORES AND GRADUATION RATES. IN THE FIRST THREE QUARTERS OF 2015-16 SCHOOL YEAR, CMSD REDUCED THE NUMBER OF OFF-TRACK STUDENTS WITH 2,273 MORE STUDENTS ON TRACK TO MISS 10 OR FEWER DAYS IN 2016 THAN IN PRIOR YEARS.
