THE ORGANIZATION HAS BEEN OPERATING PROGRAMS DESIGNED TO INCREASE THE CAPACITY OF INDIVIDUALS AND ENTERPRISE TO SOLVE COMMUNITY PROBLEMS. OUR APPROACH HAS BEEN TO CULTIVATE AN "INNOVATION ECOSYSTEM" IN WHICH CHANGE LEADERS CAN FLOURISH IN ANY COMMUNITY. HATCH PURPOSE: THE "PURPOSE WHEEL" HAS BECOME "PURPOSEWORKS", A FULLY COMPREHENSIVE ONLINE PLATFORM OF RICH LEARNING CONTENT WITH A GLOBAL REACH. IT HAS FOUR SECTIONS WITH FIVE "ELEMENTS" IN EACH. THE FULL PURPOSEWORKS BUSINESS PLAN IS NOW DONE, AND INCLUDES STRATEGIES THAT ALLOW IT TO BE USED IN UNIVERSITY SETTINGS AS WELL AS IN COMMUNITY LEARNING SETTINGS. IN 2015 WE FOCUSED SPECIFICALLY ON THE ONE REMAINING SECTION DESIGNED TO HELP SOCIAL ENTREPRENEURS COMPLETE THE BUSINESS PLAN AND PREPARE TO RAISE CAPITAL. THIS NEW CONTENT IS NOW COMPLETE, AND WILL BE FULLY IMPLEMENTED INTO THE PURPOSEWORKS PLATFORM IN 2016. THIS WILL GREATLY EXPAND OUR POTENTIAL REACH AND ANSWER THE CALL FOR A TOOL AND PROGRAM THAT CAN BE ACCESSED ANYWHERE IN THE WORLD WHERE THE WEB IS ACCESSIBLE.

4b (Code) (Expenses \$ 353,276 including grants of \$) (Revenue \$ 282,469)

HATCHLAB: HATCHLABPDX, LAUNCHED IN 2013, IS 13,000 SQ FT OF SPACE, RESOURCES, ALLIES AND EXPERTS TO HELP LAUNCH SOCIAL ENTREPRENEURS IMPROVE COMMUNITIES VIA ENTERPRISE. WE CONTINUE TO ONLY LEASE TO ENTREPRENEURS WITH A MISSION TO IMPROVE COMMUNITIES, AND WE RENT OUR EVENT SPACE TO OTHER COMMUNITY ORGANIZATIONS BELOW MARKET RATE TO HELP THEM REACH THEIR AUDIENCES AND CONVINCE AUDIENCES. WE CONTINUE TO BE FULLY LEASED WITH A WAITING LIST. THIS YEAR WE ATTRACTED OVER 250 VOLUNTEERS WHO HELPED AT 204 EVENTS HELD BY US AND OTHER NONPROFITS ON SUBJECTS SUCH AS LOCAL INVESTING, SUPPORTING FAMILIES, ACCESS TO HEALTH CARE, CHILDCARE, UNDERSTANDING MONEY, YOUTH DEVELOPMENT, FINANCIAL LITERACY, EQUITY, AND SOCIAL JUSTICE. WE HELD OUR OWN EVENTS IN HATCHLAB, INCLUDING TWO "HATCH SOUP" EVENTS, A PROGRAM THAT INITIATES BUDDING COMMUNITY CHANGE AGENTS TO PITCH TO COMMUNITY MEMBERS WHO POOL THEIR TICKET PRICE TO GIVE TO THE WINNER, THE LAUNCH OF COMCAPDX AND COMCAPOR (WHERE THE GOVERNOR SPOKE), TWO EVENTS THAT HELPED OREGONIANS UNDERSTAND THE CONCEPT AND USE OF COMMUNITY CAPITAL, AND A LAUNCH EVENT FOR THE SOCIAL ENTREPRENEURS RAISING FUNDS. OVER 1,800 PEOPLE ATTENDED THESE EVENTS AND WORKSHOPS. PROFESSIONALS, COMMUNITY MEMBERS, AND STUDENTS COME TO MEET LIKE-MINDED PEOPLE. IN HATCHLAB PDX WE PROVIDED SUPPORT TO 186 SOCIAL ENTREPRENEURS WITH PROGRAMS AND 1:1 CONSULTING AND ADVISING. IN 2015 WE HOSTED THREE WORLD AFFAIRS COUNCIL GROUPS TO SHARE OUR HATCH LAB MODEL. WE HELD 12 MONTHLY "HATCH COMMUNITY GATHERINGS" FOR OUR MEMBERSHIP COMMUNITY WITH LOCAL EXPERTS, AND HAVE BUILT A STRONG NETWORK AROUND THE WORLD WITH OTHER INCUBATORS AND LABS TO SHARE BEST PRACTICES. WE CONDUCTED 120 TOURS OF HATCH FOR VISITORS. IN ADDITION, WE HAVE CREATED A HATCHLAB IN BAKER CITY, OREGON, AN EXTREMELY RURAL COMMUNITY OF LESS THAN 10,000 PEOPLE. THIS PLACE IS GROWING TO DEVELOP INTO A FULL INCUBATOR, SPACE FOR PROGRAMMING, AND CO-WORKING TO SERVE RURAL ENTREPRENEURS.

HATCH OREGON: AFTER WRITING THE DRAFT OF OREGON'S NEW CROWDFUNDING LAW, WE HELPED LAUNCH IT INTO OREGON ON JANUARY 22, 2015, WHERE OVER 200 PEOPLE CAME TO CELEBRATE AND LEARN. OREGON'S NEW CROWDFUNDING LAW ALLOWS ORDINARY OREGONIANS TO INVEST IN SOCIAL ENTERPRISES AND SMALL BUSINESS, HELPING RETAIN CAPITAL IN COMMUNITIES AND INCREASE LOCAL RESILIENCE. WE THEN DEVELOPED AN EDUCATIONAL PROGRAM THAT TEACHES ENTREPRENEURS HOW TO USE THE NEW LAW. CALLED INVESTOR READY ACCELERATOR, THIS PROGRAM ENABLED 13 ENTREPRENEURS TO LAUNCH FUNDRAISING CAMPAIGNS FOR "COMMUNITY CAPITAL" HELPING GROW AN ECOSYSTEM FOR HELPING START SOCIAL ENTREPRENEURS. THIS ALTERNATIVE FORM OF CAPITAL THAT IS COMMUNITY FOCUSED AND LOCALLY GROWN IS HELPING RETAIN CAPITAL IN OREGON AND SERVING RURAL ENTREPRENEURS, (ALL BUT TWO OF THE ENTREPRENEURS WE HELPED WERE FROM RURAL OREGON). WE ALSO TOURED THE STATE, SPEAKING IN 22 CITIES TO TEACH COMMUNITIES ABOUT THE BENEFITS OF COMMUNITY CAPITAL AND THE NEW LAW. WE ALSO SECURED A LAW FIRM TO TRANSLATE THE LAW INTO SPANISH PRO BONO, WHICH WE HOPE TO USE IN 2016 WITH SPANISH-SPEAKING ENTREPRENEURS. BY THE END OF 2015, HATCH INNOVATION STAFF SPOKE 67 TIMES INSIDE AND OUTSIDE OREGON, SHARING THE STRATEGY AND BENEFITS OF COMMUNITY CAPITAL. FOUNDER AMY PEARL WAS ON THE COVER OF THE PORTLAND BUSINESS JOURNAL AND WON THE PRESTIGIOUS "ORCHID AWARD" AS A "WOMAN OF INFLUENCE" AS A RESULT. HATCH OREGON COM HELPED FACILITATE THE INVESTMENT OF 333,000 IN 2015 INTO SOCIAL ENTERPRISES.
