Provide materials in a variety of formats(print,AV,electronic) for patrons to use in the library or at home to enrich their lives. Materials range from very simple for young children to complex, higher level information for advanced students and adults. Materials are borrowed to learn new skills or explore an area of interest.  
The majority of library staff and activities are devoted to this service. In 2015, the library circulated 513,863 items. Over 11,919 items were delivered to homebound patrons.

Another major line to business revolves around providing assistance for information seekers, including a place to do their work and use computers and Internet Access. In 2015, over 156,094 people used the library.

Significant resources are devoted to providing programs and classes to all ages of our public. These range babytime and toddler storytimes to programs on understanding and choosing Medicare supplements. On occasion, speakers are hired, but programs are primarily prepared and presented by staff members and volunteers. Other costs include advertising, overhead, and maintenance costs and office supplies related to or used in the program. In 2015, 1176 programs were held in the library or presented by library staff with 14,358 attendees.
