In 2015, Teachers Credit Union continued to provide a superior member experience by offering competitive deposit rates and making sensible loans to membership. Despite a continued slow economic recovery, an additional location was added in 2015 through an acquisition along with additional ATMs allowing members a greater choice in products, services, and locations. New eService applications offered members better access to their accounts through Internet Banking, Bill Pay, and Mobile Banking at competitive costs. The credit union introduced a Financial Empowerment platform for its membership to improve the financial literacy of members. TCU also saw strong loan growth, and increase membership by nearly 12,000 individuals. Teachers Credit Union continues to increase products and services for the benefits of its members.




