THE CAMP ALSO SPECIALIZES IN SERVING CHILDREN WITH MINOR SOCIAL OR EMOTIONAL CHALLENGES. THE CAMP ENABLES CHILDREN TO ENGAGE IN A VARIETY OF ENRICHING EXPERIENCES SUCH AS HIKING, CAMPING, NATURE DISCOVERY, ARTS AND CRAFTS, SPORTS, CULINARY ARTS, AND SEVERAL OTHERS. THE PROGRAMMING IS DESIGNED TO FOSTER POSITIVE YOUTH DEVELOPMENT BY PROMOTING POSITIVE VALUES AND BEHAVIOR.
