Next, the Foundation sends out grant agreements for the outside organization to sign. An award program is held in June or December (depending on cycle) for the grantee to receive the money. Pictures are requested in digital form from each applicant along with their final report. All funds follow the above granting procedures with the exception being donor advised funds. The fund originators make recommendations to the Board of Directors, rather than the Grant Committee. The Executive Director has the authorization to sign grant checks up to \$5,000. Any grant over \$5,000 requires two signatures, and one signature must be the Treasurer or the president of the Board of Directors. All fund statements are generated and reviewed by the Executive Director before they are mailed to the donors. |
