Facts And Circumstances Test

Partners in Public Health (PPH) strives to enhance the overall health of the Johnson County community through its programs and services. Clean Air Kansas City is an education and community outreach program to address elimination of exposure to tobacco through presentations, workshops and the media. Most of the population of Johnson County, approximately 570,000 individuals, benefited from this program in 2015. The WIC Community Garden grows fresh produce for distribution to Kansas WIC (Women, Infants and Children) families. Approximately 3,400 pounds of fresh produce was harvested and distributed to WIC families. The Safe Kids Johnson County Program offered training and education classes on child safety issues to approximately 23,000 people. Members of the PPH Board of Directors have extensive experience in the public health and mental health areas. There are also members who have long-term volunteer experience with the county health and wellness task force and Safe Kids coalition. The Treasurer of PPH has more than 30 years' experience in the public health arena and in community programs that impact the overall health of residents. PPH has a continuous program for solicitation of funds through programs and services designed to attract support from individuals, government entities, and other publicly supported organizations. Renewed efforts by Board members are being made to obtain the funding needed for PPH's programs. In addition, the Safe Kids coordinator for Johnson County assists in requesting grant funds to support the activities of the Safe Kids program. This renewed commitment to raising funds will strengthen PPH's public support percentage in future years.
