The People's Harm Reduction Alliance (PHRA) operates a syringe exchange program in Seattle's University District. Through this program PHRA provides injection drug users with the resources they need to avoid HIV and Hepatitis C infection, prevent death and lead healthier lives. Specifically, PHRA provides drug users with sterile syringes, clean pipes, education related to safer drug use practices and referrals to drug treatment and Naloxone, a lifesaving medication that can reverse opiate overdose. In 2015, 1,875,232 million sterile syringes were distributed through the University District needle exchange program through 9,540 individual interactions.	

4b	(Code) (Expenses \$ 102,079 including grants of \$) (Revenue \$)
In addition to the fixed-site syringe exchange program in Seattle's University District, PHRA also operates a mobile syringe exchange that delivers safer injection drug use supplies to suburban and rural regions of King County. This second syringe exchange program ensures that all King County residents, no matter where they live, have meaningful access to sterile syringes. PHRA's mobile exchange distributed roughly 1,942,200 million syringes in 2015. We also operate a mobile bike delivery service in Olympia Washington.

People's Harm Reduction Alliance has assumed responsibility for the operations of the Emma Goldman Youth Homeless Outreach Project (EGYHOP) which provides homeless services and clean syringes to injection drug users in Washington State. In 2015 the Portland Peoples Outreach project which provides homeless services for low income folks living in the Portland Area along with providing clean injection equipment for injection drug users. In December 2015 the Ostrich Bay Needle Exchange location was opened in Washington State.
