We Belong Together (WBT) led a number of actions to inject specific values and concerns of women and young people into the immigration debate. In the latter half of 2015, WBT pivoted to working on administrative and enforcement relief for undocumented immigrant women and their families. NDWA developed an information hub and other materials for immigrant women on relief options and their rights

Fair Care Labs holds the development of NDWA's private sector strategies. NDWA launched the Fair Care Pledge to promote fair hiring practices among private domestic employers, developed and launched the Good Work Code to guide the online and on-demand economy in creating good work, and ran experiments for incubating potential social enterprises for the domestic work industry

State Bill of Rights. In collaboration with the Brazilian Workers Center, NDWA campaigned for and won a new law advancing the rights of domestic workers in the state of Connecticut. NDWA also campaigned in Illinois for a bill of labor rights for domestic workers and will be reconsidered in the 2016 legislative session. In NY, MA and CA, where laws have already been enacted, NDWA initiated implementation efforts to ensure domestic workers are aware of their new rights and protections
