What is the organization's primary exempt purpose?

The mission of Willow International is to rescue and provide restorative aftercare services to victims of human trafficking in Uganda. Our aim is to end human trafficking in Uganda and empower survivors to not only be free from slavery, but to heal from trauma and live full, healthy lives.

The mission of Willow International is to rescue and provide restorative aftercare services to victims of human trafficking in Uganda. Since our work began in 2009, we have helped rescue and provide aftercare services to 161 survivors. Our aim is to empower survivors to not only be free from slavery, but to heal from trauma and live full, healthy lives. We work to restore dignity and provide opportunities that empower each survivor we work with to thrive. We serve 2 populations of sex trafficking victims: (1) Domestic victims in Uganda. We partner with leading NGOs and local officials to rescue victims. After rescue, victims are matched with a case manager who completes a holistic assessment and an individualized care plan. This plan addresses the victim's health, education, mental wellbeing, psychosocial and spiritual needs. The program duration ranges depending on the severity of the client's victimization and the stability/safety of their family of origin. Our goal is to empower each girl to heal from trauma, be free from re-victimization, be reconciled with family relationships, and eventually resettle with relatives who will provide ongoing support. (2) International victims. For these rescues, we partner with IOM and organizations in China and Thailand. Partners identify and rescue victims and Willow assists in repatriation, residential support, and aftercare services. Victims are matched with a case manager who makes a holistic assessment and creates an individualized care plan. We offer residential services as well as external case management for clients. The goals for these clients are the same as domestic victims, though we include a strong emphasis on developing self-sufficient livelihoods. For both populations, we have an array of services that are built upon a strong foundation of Christian faith: vocational and educational scholarships, counseling, therapeutic interventions, leadership development, life-skills training, business skills development, access to capital, spiritual development, mentorship, and family reconciliation. Though research on recidivism of trafficking victims is limited, estimates of re-exploitation range from 20-60%. Our program boasts a mere 5%. We credit this to the deep investment that we make in each individual and the research-based M&E system that tracks progress and helps case managers determine when a client is able to resettle. We focus our M&E on five key indicators: trust and belonging, resiliency and self-esteem, self-efficacy, social connectedness, and mental and emotional health.
