A "Compease" report is also generated periodically for the CEO and is provided by Human Resources to the Board of Directors (pulled when employment contract is up for renewal-typically every three years). The Board of Directors will establish the CEO compensation and other benefits level and an agreement will be drafted by the Credit Union's legal counsel for the period agreed upon by the CEO and the Board of Directors.
