3Arts AwardsThe 3Arts awards offer recognition to exceptional Chicago-based women artists, artists of color, and artists with disabilities Every year, ten Chicago artists working in the performing, teaching, and visual arts receive 3Arts awards of \$25,000, with no strings attached Artists may use the awards to defray expenses, pay off debt, purchase equipment, and focus on their creative process-or in any way they see fit 3Arts awardees are selected through a nomination and jury process, with five discipline-based jury panels comprised of judges from across the country convening in Chicago to make the selections An unrestricted cash award is significant on its own, but our awards open up many opportunities for artists
