The Compensation Committee determines the final merit increase and bonus amounts. Merit increases for both officers and managing directors are based on specific formulas which incorporate target amounts for each set of increases, and are increased or reduced companywide, based on the direction of the Compensation Committee. The Compensation Committee specifically approves compensation for officers and reviews all compensation for managing directors as well. Their actions are detailed in the Compensation Committee meeting minutes.
