 The Society conducts an annual Finance and Accounting Forum which attracts 500-600 people for over 30 sessions of educational programming and a business trade show consisting of 60-70 exhibitor booths. The program offers specific educational sessions for all the major segments of the FMS membership: CFOs, Controllers, Risk Managers and Internal Auditors, Treasurers and Investment Officers, and CEOs.

 The Society yearly offers between 24 and 27 two-day seminars/workshops on topics of import to various segments of the membership. Designed as intense, comprehensive educational sessions, the programs are CPE rich, and with typically only one to two presenters, highly interactive, practical, and hands on. Included in the seminar lineup is a five day Financial Managers School at a continuing education center in Wisconsin which immerses participants in the art of asset/liability management within financial institutions.
