We lead the Legal Impact Network, a group of the strongest advocacy organizations across 32 states working to address poverty and racial inequality. We coordinate multi-state strategies to win policy and legal victories for people living in poverty.

The Shriver Center's Advocate Resources and Training Program builds the skills and capacities of equal justice advocates, thereby increasing their impact. Our Clearinghouse Community offers advocates a place to connect with one another and find important tools and resources to advance their work.
