

Prior year correction to total Net Assets, due to insufficiency of books. Investments from the sale of a building in a prior year were not included on the prior year balance sheet.

Reason for Late Filing: A transition from an old to a new Treasurer necessitated the re-creation of a viable set of books and records.

Manual records were converted to computer, necessitating additional time.
