Shipping: Medical equipment and supplies are gathered and shipped all over the world to Lutheran health care systems. In 2015, GHM shipped 9 sea containers in support of hospitals and clinics in six countries. Seventy groups of travelers hand carried medical supplies and equipment provided by our suitcase ministry to 23 different countries.

Capacity Building: Capacity building efforts focus on increasing access to healthcare and decreasing health care disparities. Training, continuing education and scholarships were provided for village health workers, nurses, physicians, and administrators in seven countries. Community-based primary health care programs focus on health education, access to safe drinking water, improved sanitation, nutrition, and income generation to help communities take ownership of their own health, and to prevent disease before it happens.

Consulting: GHM's consulting program, Global Health Administration Partners (GHAP), recruited volunteer healthcare administrators with health care system expertise to assist partners in Cameroon, Ethiopia, Ghana and Tanzania. GHAP conducted five consultations in 2015 resulting in improved governance, financial and materials management, service delivery and strategic planning.
