Prior to making a determination on compensation arrangements subject to this policy, the authorized body shall obtain and rely on appropriate data as to comparability. Such data will assist the authorized body in determining whether the compensation arrangement is comparable to arrangements made by other for-profit and not-for-profit organizations for individuals in similar positions. The authorized body shall adequately and timely document the basis for its determination on compensation arrangements concurrently with making that determination.
