The main goal is to instill in them a desire to develop their talents to better serve others. During the year, there were 85 participants in these seminars.

An additional \$ 37,370 of donated services were provided for this program activity.

During 2015, the Organization conducted three summer leadership camps. During the year, there were 311 participants in these camps.

An additional \$9,120 of donated services were provided for this program activity.

During 2015, the Organization sponsored international volunteer service projects in Guatemala and Peru for high school students. The Organization also sponsored a trip to Rome, Italy. During the year, there were 73 participants in these programs.
