

Our mission is to bridge the gap between the Christian inmate and the local church by facilitating the integration of the former inmate into the church, workplace, and society through biblical discipleship.**

**MEET ME AT THE GATE™:** Since 1997, KHN has been working with churches, organizations, and individuals in ministering to Christian neighbors coming out of prison for whom no family-home-based program was available. Since 2008, it has worked through its affiliate organization, Koinonia House of Wheaton (KHW), to provide Christian men coming from prison a residential family-home-based discipleship program. In 2015, KHN assisted 13 individuals/families with re-entry issues, and 4 men resided at the KHW.

A highlight of 2015 was the growing participation in the Dad's Prayer Group. Between 5-20 men gather each Wednesday to pray for their children, several of whom have been or may be incarcerated. Our weekly Radical Time Out averaged 85 attendees gathering for dinner, fellowship, and worship. It is a community that welcomes everyone to experience the love and grace of Jesus Christ, regardless of color, class, culture, crisis or crime. **IN-PRISON MINISTRIES:** In 2015, KHN conducted Freedom God's Way events in 14 adult correctional centers for over 1,300 men and women in the Illinois Department of Corrections. These multi-day events focus on presenting the Gospel of Jesus Christ and preparing inmates for their return to society through practical Bible teaching, life skills, singing, story-telling, confession of sins, and communion. Christian literature and Bibles are distributed when allowed. Also in Illinois, KHN team members conducted 9 special services, including a Sunday worship service at Stateville Corr Center in which U.S. Representative Peter Roskam delivered the main teaching. Another highlight was a small team ministering to 7 boys incarcerated at the Cook County Juvenile Detention Center. In addition, volunteers ministered cell-by-cell in Pontiac and Stateville Corr Centers once each month. Beginning in October, another team began ministering twice a week in the Cook County Jail to men in one of the most difficult divisions. Within a few weeks, the staff noted a decrease in violent and disruptive behavior in this housing unit, for which we praise God! Another highlight was conducting 9 services at 4 different prisons in Louisiana, and arranging for the CEO of a major Christian publication to meet with the staff of the Angolite, an inmate-produced magazine. A first-time-ever event for KHN CEO Manny Mill was baptizing 9 inmates following two services at Dixon Correctional Center in Jackson, LA.

**GENERAL:** Expenses in this category cover activities such as helping families of incarcerated individuals, educating the public on the needs of people returning to society from prison, and ministering to donor families. In 2015, KHN staff assisted 24 individuals and families through formal and informal advisory sessions. KHN staff members also spoke/taught on 20 radio programs on 12 stations broadcasting from 7 states; 13 services or small groups for 5 churches in 2 states; and 5 schools/para-church organizations or pastors' meetings.
