Form 990-PF, Part V – Qualification Under Section 4940(e)

The Wyatt Foundation commenced active business operations in calendar year 2015. The Foundation is a successor private foundation that received all of the assets of the Tasajillo Charitable Trust (EIN# 76-0537229) upon its voluntary termination pursuant to Internal Revenue Code Section 507(b)(2).

Pursuant to Revenue Ruling 78-387, the tax attributes of the Tasajillo Charitable Trust transferred to the successor private foundation, the Wyatt Foundation. Accordingly, for purposes of its Section 4940(e) calculation, the Foundation is utilizing the five year base period reported on the Tasajillo Charitable Trust's last filed full-year Form 990-PF tax return (for the year ending December 31, 2014).

Form 990-PF, Part XII – Qualifying Distributions

The Wyatt Foundation made qualifying distributions (including administrative expenses) of \$452,538 for the year ending December 31, 2015. In addition, its predecessor foundation, The Tasajillo Charitable Trust (EIN# 76-0537229) made qualifying distributions of \$980,529 in its final short-period tax year ending October 31st, 2015. Since the Form 990-PF does not accommodate the unusual circumstances of the Trust's dissolution and subsequent inclusion of the tax attributes into the Wyatt Foundation, the Foundation has reported the \$980,529 in qualifying distributions [the Trust made for the short period ending October 31, 2015] on Part XII, Line 2 so that the total qualifying distributions will flow appropriately to Part XIII of the 990-PF.

Form 990-PF, Part XIII – Undistributed Income

While the Foundation did not calculate any undistributed income on its Form 990-PF for the year ending December 31, 2014 (as it had no activity), it is recording the Trust's undistributed income of \$886,201 for the year ending December 31, 2014 to be satisfied by the combined qualifying distributions made by the Trust and the Foundation in calendar year 2015.

The Foundation has made sufficient qualifying distributions to cover its undistributed income for the year ending December 31, 2014. The following table illustrates the qualifying distributions as applied on the 2015 Wyatt Foundation Form 990-PF.
