BLH offers a full range of acute care for inpatients and is a well-established destination for surgery, genatrc psychiatry and emergency care. BLH operates a full-service, 24/7 emergency department that treats about 19,878 patient visits annually, regardless of their ability to pay. Outpatient services are provided at the hospital, as well as at rural health clinics in Paw Paw, Decatur, and Mattawan. In 2015, IN FURTHERANCE OF ITS MISSION, BLH INCURRED NET COMMUNITY BENEFIT EXPENSE OF \$3,008,951.	








This can be found in the attached Audited Financial statements on page 9-10 under Note 2 Significant Accounting policies for Accounts receivable Part III, Line 2. Uncollectible amounts are written off against the allowance for doubtful accounts in the period they are determined to be uncollectible. Bad debt expense is disclosed based on gross charges. For Line 3 bad debt writeoffs support the community by providing a portion of services without payment. The amount of bad debt expense attributable to patients eligible under the financial assistance policy was estimated by reviewing the bad debt detail for a specific write-off code.</p>
