Pursuant to the terms of the agreement between the Foundation and the Nagaraju Charitable Trust, the funds distributed to the Trust by the Foundation are used exclusively for those charitable purposes of the Charitable Trust. These include the maintenance and support of the **Suvarnamukhi Ashrama Religious Center and Educational Campus** – which provides educational and humanitarian programs for the financially needy and impoverished youth of the community. In order for the Nagaraju Charitable Trust to remain eligible to receive distributions from the Foundation, the Trust is required to comply with a number of conditions. These conditions include submission of financial reports and a prohibition against diversion of the funds for any purpose other than charitable.

The Board of Trustees of the Foundation meet annually to review the minutes of the Nagaraju Charitable Trust meetings, with copies of financial reports and budget analyses of the needs of the Educational Center. The Nagaraju Charitable Trust also submits to the Trustees of the Foundation an annual audited report dated September 20, 2016, certified by a Chartered Accountant, including attachments further detailing its financial activity and details of its re-distribution of amounts received from the Foundation. As of December 31, 2015, the Nagaraju Charitable Trust has expended \$ 207,550.00 of the funds received by it from the Foundation during the year ended December 31, 2015.

Pursuant to Treas. Reg. 53.4945-5(b)(2), the Trustees of the Foundation have verified that the Nagaraju Trust has complied with the terms of the agreement. Also, the Trustees of the Foundation obtain written commitments by the Trust which satisfy Treas. Reg. 53.4945-5(b)(3).

To the knowledge of the Trustees of the Foundation, there has been no diversion of any portion of the funds paid to the Nagaraju Trust from the charitable purposes specified for such funds.
