MHP Salud receives funding from Center for Medicaid and Medicare Services to conduct a Navigator to Marketplace Insurance program. The Navigator program trains and certifies several Community Health Workers as Navigators. Navigators are trained to provide help to consumers, small businesses and their employees as they look for health coverage options. Navigators provide free and unbiased information to anyone who requests assistance, and the assistance is designed for anyone seeking health coverage.

MHP Salud's Navigators provide their services in community-based settings in Texas' Rio Grande Valley, specifically to residents in Cameron, Hidalgo, Starr and Willacy Counties

In 2015, MHP Salud directly served 7,252 individuals, of those individuals, 2,739 received one-on-one assistance from a Community Health Worker to apply for insurance through the Marketplace. There were over 80 events facilitated by MHP Salud Community Health Workers educating community members on insurance enrollment.
