Grants are awarded which may be used for medical expenses, basic living expenses, or funeral expenses. Anyone who has worked at least five years full time in the industry-whether behind the curtain or behind the camera, or for one of the companies who manufacture or supply products and services to the industry-may apply for a grant. Since the first grant in 2006, almost \$625,000 has been awarded to pay for necessities such as rent/mortgage, utilities, medications, doctor visits, and health insurance premiums. Behind the Scenes brings help and hope to our colleagues in their darkest hours.
